with honors from Indiana University, where she studied violin with Tadeusz Wronski and Josef Gingold. She has had the great privilege of studying SECE with the creators of the curriculum, Dorothy Jones and Sharon Jones. Mrs. Schuh also performs with the Möbius Chamber Ensemble and as a freelance violinist and violist in the greater Houston area. She and her husband, Todd, reside in Sugar Land, Texas.
